MEDICINE HAT



Pollution Probe is pleased to announce that Medicine Hat is the recipient of the 2015 Pollution Probe Award. The community's efforts to end homelessness are an inspiring example of what can be achieved when local groups are empowered to make positive, tangible change.

Pollution Probe believes that human health is at the core of sustainable development relying on communities such as Medicine Hat that are engaged, empowered and vibrant.

In 2009, Medicine Hat developed a five-year strategy to end homelessness, *At Home in Medicine Hat: Our Plan to End Homelessness*. From 2009 to 2015, 931 formerly homeless individuals have been housed in Medicine Hat, including 291 children. Medicine Hat is on track to meet its goal to end homelessness by the end of this year.

The award will be accepted this evening by Jaime Rogers of the Medicine Hat Community Housing Society on behalf of the community of partners, supporters and volunteers that contributed to the success of Medicine Hat's housing first initiative.
